After careful examination of the information contained in the references read above and in pursuance of the recommendations of the inspecting officer in the letter 6th read above, the District Educational Officer, Chittoor is pleased to accord **Renewal of Recognition for Classes I to V (EM) (without aid) for the academic years from 2019-2020 to 2028-2029** in respect of **Camford English Medium Primary School, D.No.28-1407, West Campus, Ganganapalle, Chittoor, Chittoor District**, subject to following conditions.

- 1) That the society shall abide by the instructions / rules and regulations made by the Government of authorities Officer from time to time.
- 2) That the Educational Institution shall serve the needs of the locality more particularly
- 3) That the Instructions shall adopt the curriculums syllabus prescribed from time to time.
- 4) The School timings vacations and mid-term holidays shall be as prescribed by the Govt. from time to time.
- 5) That the qualified staff within the age limits shall be appointed as prescribed by the Government.
- 6) That the results of the institution shall be satisfactory every year.
- 7) That the records/accounts shall be furnished to the District Educational Officer every years by July at the latest.
- 8) That the list of Governing body shall be furnished to the District Educational Officer every year.
- 9) That the pay structure /fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 10) That all the conditions prescribed in the G.O.s and other orders which are not specified in these orders shall be complied with.
- 11) That the school shall not be closed without giving notice both to the parents/ District Educational Officer and competent authority at least 6 months before.
- 12) That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) That the Management should submit proposals for renewal of recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal in future.
- 14) Only single section in each class is recognized.
- 15) The Management should follow the rules and regulations prescribed in Circular Memo.No.21748/D1/1997, dated:16.02.1998 and other orders of transport authorities regarding maintenance of school vehicles/ maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport authorities as prescribed by the Govt. from time to time.

- 16) The Management should have adequate personal guide, the movement of the children to ensure the road safety and transportation.
- 17) The Management should adhere the instructions issued by the District Educational Officer, Chittoor from time to time.
- 18) The management should provide atleast 1000 books for the school library.
- 19) The Management should obtain and produce the NOC from the District Fire Officer immediately without fail.

The District Educational Officer, Chittoor has verified the application for grant of Renewal of Recognition with reference to the Inspection Report of the Deputy Educational Officer, Chittoor and also with reference to the conditions laid down in permission orders and submitted a report in his letter 13th read above.

After examining the references read above and the conditions prescribed in G.O.Ms.No.1 Education dated: 01-01-94, G.O.Ms.No.41 Education dated: 11-05-06, G.O.Ms.No.58 Education dated: 13-07-2006, G.O.Ms.No.74 Education dated: 29-09-2008, G.O.Ms.No.123 Education dated: 27-09-2008, G.O.Rt.No.730 Education dated: 29-09-2008 and G.O.Ms.No.80 Education dated: 15-07-2009 the Regional Joint Director of School Education, Kadapa hereby accords Renewal of Recognition to **Camford English Medium High School, Sy.No.382/1, 383, 384 of 72, West Campus, Ganganapalle, Chittoor, Chittoor District** for the classes VI to X (EM) for the academic years from 2018-2019 to 2027-2028 subject to the fulfillment of the following conditions.

01. That the society shall abide by the instructions/rules and regulations made by the Government or Authorized Officer from time to time
02. That the Educational Institution shall serve the needs of the locality more particularly.
03. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
04. The School times, Vacations and mid-term holidays shall be as prescribed by government from time to time.
05. That the qualified staff within the age limits prescribed by the Government for Government Employee shall be appointed as per the staff pattern.
06. That the results of institution shall be satisfactory every year.

07. That the records/accounts shall be furnished to the District Educational Officer every year 31st May at latest.

The Management is informed that as per G.O.Ms.No.1 Education dated: 01-01-1994, the fee collection from the students shall be allocated as to meet the following requirements: -

- a) 50% of the fees collected shall be earmarked towards payment of salaries to the staff.
 - b) 15% of fees collected shall be utilized for the maintenance of the institutions towards expenditure involving the building rent, electricity and water charges, stationery office payments to be made to menial and auditors, purchase of Library books, Lab Equipment and Chemicals and expenditure involving the upkeep of the institution etc.
 - c) 15% of fees collected shall be earmarked for the developmental activities of the institution.
 - d) 15% of the fees collected shall be earmarked as management's contribution towards staff benefits like gratuity, teachers provident fund, Group Insurance scheme etc.
 - e) 5% of the fees collected shall be earmarked as personal income to the Management.
08. Library should be enriched with at least 1000 books.
09. E.W.F. Scheme should be implemented to all the staff members.
10. That the list of Governing body shall be furnished to the DEO every year.
11. That the pay structure/Fee structure fixed by the governing body shall be got approved by the DEO every year.
12. That all the conditions prescribed in the G.O. and other orders which are not specified in these orders shall be complied with.
13. That the School shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
14. That the school shall be closed for permitted to be closed only from the date on which summer vacation is declared.
15. That the society shall submit proposals for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the order. However by the end of April every year, the Educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time.
16. The Management has to submit the renewed fire certificate to the Regional Joint Director of School Education, Kadapa every year with in the stipulated period.
17. The Management has to submit the Audit Report of the school with audited statement of accounts of every year without fail.
18. That the affidavit as per G.O.Ms.No.41 Edn dt:11.05.2006 should submit in every year
19. The Management Should obtain fire NOC from the fire department and should submit with in three Months through Deputy Educational Officer concerned without fail. Otherwise the Renewal of Recognition will automatically cancelled.
